Muscogee Nation Gaming Enterprise Board

Representative Robert Hufft reported the MNGE Board met April 3, 2024. The Board approved DirecTV as a content provider for the sports bar. The sports bar will be opening in July 2024. They are refurbishing the bathrooms next to the bar. There will be a groundbreaking for the Eufaula Casino June 4, 2024. The Board also met April 17, 2024. The month of April revenue is looking good and the distribution for the March was 14.1 million. The next meeting is May 1, 2024.

Muscogee Nation Businesses, LLC Board

Representative Dode Barnett reported the 2nd quarter from staffing solutions focused on execution of existing contracts. They also submitted 9 federal proposals, completed their annual update as required by SBA, and attended various job fairs, resource fairs across the reservation. Muscogee Asset Protection is now 8(a) certified and are bonded. That happened during the second quarter. They have a total of 355 employees, 25 are Muscogee (Creek). MNB, LLC is almost ready to close out their FY23 audit, and distributions to the nation totaled \$30,000.00.
