## **Muscogee Nation Gaming Enterprise Board**

Representative Robert Hufft reported the MNGE Board met August 7, 2024 and the MNGE directors gave report and Bank of Oklahoma gave a report on their 401K performance on the last year. The Board approved the disposal of assets from One Fire Casino. There was also an update on the flood litigation. Next meeting is August 21, 2024.

## Muscogee Nation Businesses, LLC Board

Representative Dode Barnett reported the Board met last month discussed their last quarterly report, which was reported to the Council already. Also, they are still in search of a new property. They have couple of joint ventures proposals that are under NDAs, which can't be discussed on the record. They had a strategic planning earlier this month.

## College of the Muscogee Nation Board of Regents

Representative Anna Marshall reported the Board met August 19, 2024. They have 219 students enrolled and the first day of class is August 26. A guest speaker attended the meeting and discussed the shortage of court reporters in the state of Oklahoma, and maybe MCN could help with the certification process for court reporters. Another topic discussed was the Exhibit Hall. They are waiting on a generator for the enclosure. The Dining Hall could be finished by October or November. The American Indian Higher Education Consortium will be hosting the AIHEC Basketball Tournament in Tulsa, but the finals will be held at MCN Dome in March 2025. October 11, 2024 is the 20<sup>th</sup> Anniversary of CMN. The celebration will be held in the Lecture Hall. Viewpoint, with Dennis Quaid, will be filming Tuesday, September 24, 2024 on the CMN campus. They will be covering sovereignty, language and culture. There are also some grants coming up that will help with digitizing the language and running apps. They have some planning grants for STEM and AI classes, as well as, the Mvskoke Dictionary. CMN recently hired eight people, with many of them being former graduates of CMN who have obtained their Master's Degree.

#### Myskoke Loan Fund Board

Representative Nelson Harjo Sr. reported the Board is working on software to enhance the program and help the officers with better reports. Next meeting is September 11, 2024

### OneFire Holding Company, LLC

Representative Patrick Freeman Jr. reported a meeting was held August 20, 2024. Discussion points were lease update, lease reviews and HR policies. The FY23 audit was turned in last week, with no significant issues.
